All the recommended candidates are required to submit No Objection Certificate from Bar Council of Punjab & Haryana and a Bank Demand Draft of Rs.2,000/- in favour of Pay & Accounts Officer, Department of Legal Affairs, New Delhi by Speed Post OR Registered Post only within a period of 30 days' of issues of this letter. Besides this, the candidates are also required to submit any other document which has not been submitted by the candidate at the time of Interview and asked him/her to submit afterwards.
